First Meeting of Indian Point Nuclear Decommissioning Citizen Advisory Panel (NDCAP) to Convene Next Week

Buchanan, NY—The Indian Point Nuclear Decommissioning Citizen Advisory Panel (NDCAP) will hold its first meeting on June 13. The panel's formation was announced on March 28 by Village of Buchanan Mayor Theresa Knickerbocker, Town of Cortlandt Supervisor Linda Puglisi, and several other local officials in order to facilitate an open dialogue among key stakeholders preparing for the closure and eventual decommissioning of the Indian Point Energy Center in 2020 and 2021.

"The purpose of this panel is to enhance open communication, public involvement, and education on the Indian Point decommissioning issues. The CAP will serve as a formal channel of community involvement with Indian Point," said **Mayor Knickerbocker**.

Supervisor Puglisi said, "I am very pleased to serve as the Vice-Chairperson of our newly established Indian Point Advisory Panel along with Mayor Theresa Knickerbocker, Chairperson of this panel, which will monitor the decommissioning of the Indian Point nuclear plants. These plants currently owned by Entergy will close in April 2020/2021 and then Holtec, Inc. will take ownership to do the decommissioning (dismantling) of the plants. This panel is comprised of other elected officials in our area, citizens from Buchanan and Cortlandt and a member of the environmental groups in our area. The panel will disseminate information to the community as we proceed on this long journey of decommissioning."

This meeting is open to the public and all are invited to attend. A public comment period will be included in the meeting.
