Mayor Theresa Knickerbocker welcomed everyone to the meeting.

TKnickerbocker: Tonight we will be focusing on the Entergy employees. Our presenter will be Tony Vitale, Site VP Indian Point Energy Center and a presentation by the NYS DPS, Tom Congdon, Deputy Chair and John Sippos, Deputy General Counsel.

This is one of many more to come of these meetings. As the Mayor of Buchanan, the host community - not only the loss of revenue to the village was and is a concern but also what would happen to many of the employees who kept us safe all these years. They are our neighbors and friends who will be losing good paying jobs. Generations of families worked at Indian Point. I knew many of the good hardworking people that built IP. Because of Covid it has been difficult to plan a thank you for them but I am hoping to still find a way to thank them for operating the plant safely all these years. They are very much appreciated by the Buchanan residents. I am interested, this evening, to hear the status of the employees at IP. Supervisor Puglisi and I are here for the employees and will do whatever it is we can do for them. Linda, I will miss you when you retire but hope you will stay involved, you have been my right-hand person through this all.

LPuglisi: Thank you Theresa for your kindness and your hard work. Along with Joe Hochreiter, the 3 of us communicated immediately when we found out in January 2017 that IP was to close. We decided that we would work together because we were all facing these challenges - the loss of jobs, the loss of revenue, etc. There are many issues that we knew we were going to face as years progressed. We started the Local Community task force and held monthly meetings, we went to Albany to testify, we went to Editorial Boards, we talked to a multitude of reporters, we updated our boards on what we were working on and doing for the community. We posted reports and updates on FB and websites. On our local task force, we had realtors, the Chamber of Commerce, members of our boards, Labor, Librarian, Fire District of Verplanck - we had a myriad of people on the task force. We also had elected officials: County Executive George Latimer and our County Legislators Colin Smith and Catherine Borgia - Sandy Galef, Peter Harckham have submitted legislation - 3 Bills that are very important. We thank the Governor for signing these Bills because they are going to be beneficial to us. (This is a piece of the puzzle). Working together, side by side with the Mayor, her Trustees, the Superintendent and their Board - we have all been in this together, without any dissension and we will continue to work together. Even though I am retiring at the end of this year, I will still be there with you and for you whenever you need me. This is the history and I wanted to remind everyone what we have done. We have joined the NYS Task Force with Mr. Tom Congdon and we were pleased to be a part of that, including the DL English report to talk about perhaps development of some corners of the 240 acres, sooner rather than later. Tom has been terrific to work with. Now this important panel has been established and I thank you Theresa for Chairing it. I will continue to be with you on this journey.

Panel Members were introduced:

Tom Congdon:

I am the Executive Deputy, Department of Public Service and the Chair of the Indian Point Closure Task Force. I am very proud to partner with Mayor Knickerbocker, Supervisor Puglisi, our State Representatives - Sandy Galef and Peter Harckham, our County Legislators, our County Executive, our friends and brothers in Labor. I really appreciate the opportunity to be with you tonight to work with all of you on the NYS Task Force. Our Department of Labor has been onsite for the past many months, working with the employees on future employment opportunities and providing them with information on services the State has to assist them in finding new employment in New York State.

Manna Jo Greene: I am the Environmental Director Hudson River Sloop Clearwater and I have been following this process since 9/11. I am also a Legislator in Ulster County. I am an activist and an elected official and I am honored to be part of the NDCAP.

Richard Funchion: I am the Deputy Mayor of Buchanan and I am glad to be part of this. I thank you, Linda, for all of your service. You have been a great help to the Town of Cortlandt and to Buchanan and we will dearly miss you.

Sandy Galef: Assemblywoman and kudos to Linda and Theresa and kudos to Tom Congdon who worked really hard to be sure we got those 3 Bills passed and signed by the Governor. It happened on New Year's Eve at 8 pm. The other good news - the Cessation Fund in the budget went from \$69 million to \$140 million.

TCongdon: That is really the authorization language for the program to ensure that it takes into account the full award for the IP community in addition to the other known, affected communities. That is the known, full exposure for the fund so the authorization was an important thing that was included in the Executive Budget. Thank you for mentioning that.

TCarey: Thank you Sandy and Senator Harckham for the 3 Bills regarding IP and I thank Mayor Knickerbocker and Supervisor Puglisi. This all started 4 years ago and it seems like yesterday. We are still fighting and we have to keep up the fight and get what is right for the people. I thank you for what you have done for Labor. As a Labor leader here in this community - Linda, Theresa, Sandy Galef, Peter Harckham and our Board of Legislators have been phenomenal. I am proud to be part of this.

John Sippos: Deputy General Counsel, the Department of Public Service. Thank you for the invitation.

Tony Vitale: Site VP Indian Point Entergy Center.

John O'Mara: I am a retired Chemical Engineer from the Department of Environmental Conservation as a Regional Spill Engineer. I am still involved and I tutor members of the Hazmat Team. I am here to assist in any way I can.

Will Smith: VP Local 1-2 Utility Workers - we represent the workers at the plant.

Al Libertore: Business Agent with Teamsters Local 456. We represent Security Officers at IP. I would like to congratulate Linda Puglisi on her retirement.

Mike Twomey: Entergy Corporation's representative of the Panel.

Richard Becker: Deputy Supervisor, Town of Cortlandt. I am working under Supervisor Linda Puglisi and she is teaching me the ropes. She has been the leader for many years and we all wish her well but she isn't going anywhere for a while.

Don Dwyer: Local realtor and parent of a student at HH schools and 20-year homeowner in Montrose. Thank you to all the labor at IP - I never once felt unsafe because of the quality people you have there.

Joe Hochreiter: Superintendent of the Hendrick Hudson SD. I thank the State and the Governor's team on being very available and diligent partners as we go through this closure process. I wish Linda a very healthy, long and safe retirement. It is great working with you and I know our work will continue.

Tito Davila: I am the IP Liaison for Senator Peter Harckham.

Catherine Borgia: County Legislator representing the area around IP and I am here to partner with all of you to make sure this transition is as safe and equitable as it can be.

Peter Loughran: I am the Four County Coordinator for IP. I work in the Office of Emergency Management in Westchester County.

Deb Milone: President Hudson Valley Chamber of Commerce. I thank Linda and Theresa for including the business community on this Panel.

Colin Smith: it has been a pleasure to be part of this process. Thank you Supervisor Puglisi for all of your service and all of the work you have done. Your leadership has left a mark and you will be greatly missed upon your departure. I am the County Legislature for District 1 which includes Buchanan and where IP is located.

Eileen Absenger: I am a resident of the Village of Buchanan and on the Planning Board. I wish Linda happiness in her retirement.

Minutes of December 10, 2020 - no comments or corrections:  
A motion to approve Linda Puglisi, all in favor - aye.

Presentation by Tony Vitale:

TVitale: Thank you Mayor Knickerbocker and Supervisor for your time this evening and for your efforts representing the thousands of people, including some of our employees who live in the Village and the Town around IP. Thank you for giving me time to share information with you about the most important assets at IPEC, our employees, and some of the efforts being taken to facilitate the transition to a new reality after it is permanently shut-down, defueled and transferred to a new company for prompt decommissioning.

The focus of tonight's discussion is about our employees and all we are doing as a company and as a community and as a State to make this difficult transition as stress-free as it reasonably can be expected.

Despite the pending shutdowns Indian Point's leadership team is and always will remain focused on safe and reliable operations of Unit 3 through its final shutdown as we prepare for site decommissioning. Just over 4 years ago when the permanent shutdown of the IPEC was announced, a dedicated Decommissioning Planning Organization was formed, led by Rich Burroni. This Decommissioning Organization is focused on the decommissioning milestones, separate from the staff that is safely operating IPEC Unit 3 and maintaining IP Unit 2.

My role as site VP remains the health and safety of the public by operating our Units safely and error free. Whether we have 85 days of operation left or 20 years of operation. IP remains

subject to all NRC oversight and regulation and licensing requirements and all of the activities that go along with that.

At Entergy Corp. and IP, we understand and accept our role in the community to operate with complete transparency and open lines of communication with our numerous local, state and federal stakeholders.

Despite the limitations imposed by Covid-19 and its limit on face-to-face meetings, we continue to participate in virtual meetings to update our stakeholders on key issues. The IP Community Advisory Panel is one example of that.

There are 2 websites where decommissioning information can be found: One administered by the Village and Town and another listed by Entergy ([indianpointdecommissioning.com](http://indianpointdecommissioning.com)) that contains a lot of information regarding Indian Point's decommissioning.

Looking forward, sometime in the month of May, the separation of about 300 employees from Entergy from IP will occur. Entergy remains compliant with labor regulations and will be distributing WARN Act notices (Worker Adjustment and Retraining Notification) to all impacted employees and some local officials. We expect this mailing to occur about Feb. 12, 2021 with an email and also a hard copy mailed to their address. These notices will contain the expected separation date for each employee, the name of the Entergy contact for questions and gather information and other information required by the federal/state laws.

At the time of the shutdown announcement Entergy committed to a talent absorption process (TAP). Any and all qualified Entergy employees at IP that are willing to relocate will be offered a position within the company.

At the end of May 2020, following the permanent shutdown and defueling of Unit 2 approximately 41 employees took advantage of the Talent Absorption Program and relocated and assumed new roles within Entergy in other parts of the company. An additional 49 employees took advantage of voluntary early separation packages so they could get on with the next phase of their lives - retirement or work outside of Entergy.

We continue today with the Talent Absorption process. (TAP - Round 2). Currently approximately 130 employees at IP have expressed interest in TAP and transferring within the company following the permanent shutdown and defueling of Unit 3, in late May 2021.

Entergy has hosted multiple events where employees can learn about opportunities within the company. Some have been in-person events, prior to the pandemic and others virtual. These events were attended by Entergy businesses leaders and employees from throughout the company and employee families were welcome to attend. Topics ranged from job opportunities to schooling, to cultural attractions and favorite foods in different regions of the USA where Entergy operates. It was all done in an effort to help our employees make the best decisions for their future.

For the employees not interested in the TAP our dedicated nuclear professionals have opportunities in the Phase 1 decommissioning organization. Phase 1 will begin after Unit 3 is shut down and defueled in late May. This phase 1 staffing organization at IP will consist of 312 current Entergy/IP employees when completely staffed.

Entergy has hosted a number of workshops and provided resources to assist our employees in their career transitions. 401K and retirement savings strategies, pension sessions, benefit sessions and 2 open houses (one in person with over 500 employees attending) to hear about opportunities elsewhere within the company and a virtual open house done in Aug. 2020 which we provided the same kind of information. We also had prompt and personal information provided by the employees that have already transferred, where they could portray how that transition was and how their families were doing to lessen the stress that some employees may be feeling. We have also provided free counseling to our employees who are having a difficult time with the plant's closure; the possibility of a complete relocation and the pandemic has complicated this also. Entergy does really care about its employees and all of this was done to assist our employees through this very difficult transition to make it as stress-free as possible and allow us to operate our Units as safely and error free to protect the health and safety of the public.

In addition to the support that our employees are receiving from the corporation, the State government and local government, the support is evident. We are working with the NYS Department of Labor for the benefit of our employees. We have held numerous meetings and seminars to identify what resources are available in NYS, and there are many. We continue to hold regularly scheduled "All-Employee" meetings to provide information to our employees about the transition to decommissioning and future options. Entergy is also working with the US Dept. of Labor on additional ways that may be available as a supplement to those available in NYS also known as the Trade Adjustment Assistance Trade Act (TAA) for our employees.

NYS has been extremely supportive of our employees. They have held 10 separate training sessions starting in 2019 with resume writing, interviewing techniques, how to use LinkedIn and the State employment site. Many of these sessions have been one-on-one. Nearly 300 employees have participated in these. They are also stored on the Entergy intranet to review.

In closing, our focus at IP and my #1 priority has always been to protect the health and safety of the public and our employees and operate the plant safely and error free. The actions we discussed here were about just that; lessening the stress to our employees from our final shutdown and decommissioning, by providing ample opportunities for them to make the best informed decisions regarding their future both personally and professionally.

TKnickerbocker: I am happy to see the support these dedicated and hardworking employees are receiving. It wasn't their choice to separate from the company but I am glad the company is there to support them and help with their future.

LPuglisi: I am really pleased to see the plan that Entergy put together for their employees. That is terrific. When you start the defueling process, how long will that take?

TVitale: Approx. 12 days from the actual shutdown that will occur on April 30th to the time all the fuel is removed and in the pool and the vessel-head is landed. We don't give out too much information on this process.

TCarey: Entergy has set the gold standard for what they do for this community, our fire district, our schools, our small/big businesses and Labor. Entergy has been first-class. I can't thank you enough; I was a general foreman at both plants for a time and it is bittersweet to see you go. It was one of the safest work environments that I have encountered.

TVitale: Thank you Tom. I learned many things from your father working at the plant. The skill and quality of the Labor force that you provide is unmatched anywhere else in this industry.

SGalef: I would like to compliment the employees at IP for providing megawatts of power over so many years. Are there 750 employees there today?

TVitale: Yes, today.

SGalef: We have a lot of employees, still that we need to find positions for.

TVitale: There are about 300 that will be separating from the company but out of those 300 about half are retirement eligible. That leaves the rest we are working hard to place. We started with about 950 employees.

ALiberatore: Entergy has been a great corporate neighbor. As far as the security officers quite a few are being transferred to other locations and not necessarily in security positions. I believe Entergy did a great job in placing our members and assisting them in their retirement. We may not lose many members and that is a good thing. I want to thank you for working with us on that and keeping many of our security officers employed.

TCongdon: An excellent presentation. I appreciate the comments and the notes about the other resources being applied to assisting the employees. Has there been any coordination with the regional utilities on potential opportunities at the utilities?

TVitale: The short answer is yes but I am not going to expand on that at this time as we firm up exactly what those opportunities will look like.

Tom Congdon - the NYS Department of Public Service.

TCongdon: The topic is the legislation signed by the Governor that was sponsored by Assemblywoman Galef and Senator Peter Harckham. With the support of many of you we communicated the interest of the local community, the Labor workforce, the taxing jurisdictions and there was positive engagement from the Governor's office. There were some negotiations around the Bill that have resulted in some technical amendments. As a review, in the Executive budget there was an expansion of the authorization to the ESD (Empire State Development) which administers the Power Plant Cessation Funding Program. That authorization was increased to \$140 million which is the amount that is the known expense for the full award for the IP community, over the 7 years, as well as the other communities affected by power plant closures for the taxing jurisdictions. That was a very positive piece of the Governor's executive budget. We are hopeful that it shouldn't be too controversial to move through the budget process. That is the authorization in the budget for the program. We have a separate process underway at the PSC to establish the recurring funding mechanism to ensure that it is fully funded on a going-forward basis and there is not a need for annual appropriations. We are in a very solid position regarding the Cessation Fund due to the strong, coordinated approach that we have taken as part of the State and Local task forces to communicate the needs. Thank you very much for your partnership on all of that.

JSippos: I was asked to provide a brief summary of the recent Legislative events. Last year the Legislature past and the Governor signed Bills relating to tax issues and those legislative items would provide for:

1. The continuation of Payments in Lieu of Taxes (PILOTS) for retired facilities.
2. The ability to tax Spent Fuel Storage Systems.

Also at the end of last year the Legislature and the Governor agreed to the Chapter Amendments regarding various legislative initiatives. Legislation was introduced last month by Senator Harckham and Assembly member Galef that would provide for the employees of the IP nuclear plant to be paid certain wages (not less than the prevailing wage) in the event that the plant is sold, transferred or leased. It would provide for a transferee or a purchaser corporation to be bound by collective bargaining agreements applicable to the current workforce.

3. It would clarify and confirm that the Public Service Law is applicable to retired nuclear power reactors and their support systems and structures, your storage facilities and their property.

The DPS is working to establish an Indian Point Decommissioning Board that would advise and assess how to protect the financial, environmental and physical interests of the communities impacted by the decommissioning, including its workforce and the continuing protection of the public safety in the area.

That is the summary of the recent Legislative efforts.

LPuglisi: We have come a long way. The extra in the Cessation Fund is a home-run and thank you for reporting that. How many communities in NYS are tapping into this Cessation Fund?

TCongdon: There are no new communities that have come into the program. The communities that closed prior to IP - Summerset and Huntley in western NY. IP is next. Authorization covers all known expenditures on the horizon.

LPuglisi: IP is next in line to tap into this fund?

TCongdon: It is not so much a function of who is in line. It is a function of when the plants close and the next community that is eligible is Indian Point.

LPuglisi: The Decommissioning Board will include locals?

TCongdon: We are starting from the NYS task force in terms of the membership there and we will grow it from that.

LPuglisi: That is important. The Mayor, Superintendent and I will continue this Panel also in parallel to that.

TCongdon: That makes a lot of sense and we view it as a compliment not a conflict with. I can envision some joint meetings but we are looking to bring the State resources to the table.

JHochreiter: In our school community we are looking at another few tough years of significant tax increases given the reduction of the PILOT. After the Governor signed into Legislation the fact that the spent nuclear fuel can be taxed gave a lot of people a sigh of relief. Could you walk us through what the timeline will look like? I think there is an understanding that this will bring immediate financial relief or the town will slap this huge tax on IP and it will bring a lot of revenue to the district in a short amount of time. I am trying to temper expectations. What does the roadmap look like to enact what the Governor signed into law?

JSippos: I want to be careful in answering that question. There are some aspects of it that I am not fully aware of and there are timelines that would be outside of the control of the PSC. It is correct that the law has been amended so that the storage facilities are now included as taxable items within the real property tax laws. The timeline is a function of the local taxing jurisdiction and appraisal process in conjunction with the taxable entity - what is the ratable. In looking at the statute I don't believe there is a specific timeline either short or long. It is a process in conjunction where the local taxing jurisdictions have the opportunity to enter into negotiations with the owner/operator and depending on what are the priorities and how the parties deal with that - there are the opportunities with the PILOT and also not to go down that route. The local taxing jurisdiction has been given the authority by the Legislative amendments to go forward much like you would in other instances.

JHochreiter: I would use this as a moment to create some communication efforts on our part at the local level because there is a big and a growing expectation that that has really great potential to help some of our short and long range financial problems, which it may but we have to communicate and temper the expectations so that folks do not anticipate something that is just not possible as we put a budget together.

LPuglisi: The 3 of us will be working together with our Town Attorney, Assessor, the Mayor, Village Administrator and with Joe and the financial administrator. It will be productive and beneficial for the school district. There has been so much progress made in the last year.

TKnickerbocker: This is the beginning of the process but we will work together on this. This has been such a great team effort.

MGreene: I wanted to focus on the Decommissioning Oversight Board. There was a lot of work and good thinking on the part of the Bill sponsors and a lot of input from community members from Labor, from local elected officials and the most recent version added in, in addition to the Governor and legislative majority appointment and legislative minority appointments and was going to add in additional local community members and additional Labor representation. There are also, in the Bills, first responders, scientists - a very comprehensive and inclusive representative body. My question for the PSC now that instead of that legislation going to the floor and passing - it would have been modified to include the local concerns and it had very wide-spread support - it is now a function of the PSC and to what extent the composition of the Decommissioning Oversight Board, the frequency of meetings and who does the appointments? How often - quarterly or more often was recommended? I want to urge that there be a period of public comment, which would be different from the IP Closure Task Force - people were able to send in public comments but it wasn't real time at the meeting. How closely with the PSC version follow the legislation proposed by Assembly member Galef and Senator Peter Harckham?

TCongdon: The directive from the Governor to establish the task force did not come with all of the detail of the legislation, other than the broad categories of the people that we should be including on the task force, which definitely includes scientific experts, technical experts, environmental representatives, local representatives and State agency resources and Labor, of course. We view the State Closure Task Force as a starting point but obviously the membership has expanded. The focus is more on the decommissioning aspects and the broader issues of the Closure Task Force. As we get closer to the actual closure a lot of the issues we have been discussing over the years and the progress we have made are addressing

some of those other aspects. The new challenge for all of us is going to be to make sure the decommissioning is done as safely as possible and that the community has a venue to be updated and express concerns. I take your point to the public comment aspects and that will be considered for our planning for this. We will look at the legislation to guide us but all those details were not included in the directive to the department to establish this and get it stood up.

MGreene: Local, State and Federal officials have been very concerned that the NRC did not and has not held a Public Hearing on the license transfer. We have been recommending and there is interest on our part of our federal elected officials to hold such a PH and we have also asked that a Joint PH, as was convened several years ago with Entergy before the introduction of the idea of transferring the license to Holtec, there was a joint PH of the Assembly and Senate that several of us attended. At that point it looked like Safe-Stor was going to be Entergy's solution instead of active decommissioning. The PSC, in addition to some unanswered questions that are being appealed by the NYS Attorney General and by Riverkeeper, the PSC has the ability for the jurisdiction essentially saying yea or nay to the license transfer. I wonder if the PSC might be in a good position to hold a PH before making its decision. Many have called for this PH and it is an opportunity to review the concerns that have been raised. Would the PSC consider hosting that with federal and state officials.

TCongdon: We can consider that, certainly and take it back. Our proceedings allow for that and we will keep you informed.

JSippos: There was an effort on the part of State agencies to get a hearing before the NRC. The NRC on Jan. 15th voted not to provide for that hearing - it was a close vote, a split vote (3-2). State agencies, including the Attorney General have sought to obtain that hearing.

LPuglisi: The Town has, as well. Do you have the authority to appeal that?

JSippos: The PSC did submit a detailed letter on the waiver aspect, which was another aspect of the transfer. We voiced our concerns over the proposed waiver of a generally applicable federal regulation that would pertain to the decommissioning trust and the scope of its funds. DPS did weigh in on this.

LPuglisi: Is there a possibility that they will hold the hearing or should we get a trip down to Washington set-up?

JSippos: Under the rules of professional responsibility I want to be careful about that. There are others on this platform that might have a view on this. It would behoove me not to provide direct advice on that.

TKnickerbocker: This agenda was to be about the employees, specifically and we have veered off the topic. Manna, I do appreciate your comments but the reason for the real-time responses so at the last meeting we just ran out of time to answer them. I thank everyone that submitted questions and Holtec did respond to those questions.

MGreene: That was an excellent presentation but I was actually talking that there was not opportunity for public comment at the IP Closure Task Force, which the PSC facilitated. You have encouraged public comment and I greatly appreciate that.

Questions/Comments from the Public:

Nancy Vann: What about the Attorney General's lawsuit?

Now that the NRC composition is going to change because of the change in administration coupled with the resignation of the current Chair of the NRC is there a mechanism for review of reconsideration of the decisions for a Public Hearing.

Dwayne Jackson: Thank you to all the workers.

Tina Bognar: Community evacuation protocols?

Courtney Williams: There are a lot of questions left and we may be losing valuable time.
